SECTION 4. FIRST AID MEASURES

General advice	Move non-essential personnel away from treatment area, spill, or dangerous area. Have this safety data sheet available for emergency/medical responders.
If inhaled	Remove to fresh air. Treat symptomatically. Get medical attention if symptoms occur.
In case of skin contact	Wash off immediately with plenty of water for at least 20 minutes. Remove contaminated clothing and shoes. If skin is burned, cover burn with a loose sterile gauze dressing. Take victim to hospital or a medical centre as soon as possible. Wash contaminated clothing before re-use.

SECTION 5. FIREFIGHTING MEASURES

Suitable extinguishing media	Use extinguishing agent suitable for surrounding fire.
